Objektif

Objektif utama penyiasatan pembuatan / industri ini adalah untuk mengumpul maklumat tentang pertumbuhan, sumbangan, komposisi dan taburan sektor pembuatan bagi membantu kerajaan dalam perancangan pembangunan dan penggubalan dasar. Data yang diperolehi daripada kajian ini juga menyediakan maklumat penanda aras dan digunakan dalam penyusunan Akaun Negara, jadual input-output dan kajian tertentu. Maklumat tersebut juga digunakan oleh penggubal dasar, ahli ekonomi, perancang dan ahli akademik bagi tujuan unjuran dan analisis ekonomi.



Unit Pelaporan

Unit pelaporan yang digunakan dalam kajian ini adalah pertubuhan. Sebuah pertubuhan ditakrifkan sebagai “satu unit ekonomi yang terlibat dalam satu aktiviti, di bawah satu entiti yang sah dan beroperasi di lokasi fizikal.”

Jenis Aktiviti Perniagaan

Merujuk kepada aktiviti utama dan sekunder. Aktiviti utama merujuk kepada aktiviti dimana pertubuhan menumpukan sebahagian besar sumbernya atau yang dapat memperolehi sebahagian besar daripada pendapatannya. Aktiviti sekunder adalah ditakrifkan sebagai mereka yang bersampingan atau berkaitan untuk aktiviti utama. Pengelasan industri pertubuhan ini adalah berdasarkan aktiviti utamanya dan selaras dengan Klasifikasi Piawai Perindustrian Malaysia (MSIC) 2008. MSIC 2008 mematuhi Klasifikasi Standard Perindustrian Antarabangsa Aktiviti Semua Ekonomi (ISIC) Rev. 4 , United Nations.



Status Undang-Undang

Status Undang-Undang

Status undang-undang sesebuah pertubuhan telah ditakrifkan seperti berikut:

i. Hak Milik Perseorangan

Ia merujuk kepada perniagaan yang dimiliki oleh orang perseorangan untuk mendapatkan keuntungan sendiri. Pemilik mempunyai hak eksklusif untuk mengawal operasi pertubuhan.

ii. Perkongsian

Ia merujuk kepada sekumpulan individu yang telah bersetuju untuk mengkontrak dan menjalankan perniagaan dengan matlamat untuk mencari keuntungan. Semua pemegang saham atau mana-mana satu boleh menguruskan perniagaan untuk semua pihak.

Perkongsian perniagaan ini hendaklah mengandungi ahli sekurang-kurangnya dua orang dan tidak melebihi had maksimum dua puluh orang.



Status Undang-Undang

iii. Syarikat Sendirian Berhad

Ia merupakan sebuah perbadanan swasta yang ditubuhkan untuk menjalankan perniagaan dengan tujuan untuk mencari keuntungan. Saham dipegang secara tertutup oleh pemegang-pemegang saham yang mempunyai kawalan terhadap operasi syarikat. Ia didaftarkan dengan tanggungan berhad.

iv. Syarikat Awam Berhad

Syarikat awam berhad juga merupakan sebuah perbadanan swasta yang ditubuhkan, dengan tanggungan berhad, oleh sekurang-kurangnya dua orang untuk menjalankan perniagaan dengan tujuan untuk mencari keuntungan. Saham syarikat awam berhad ini dipegang secara terbuka, dan dalam hal suatu syarikat yang disenaraikan di bursa saham, sahamnya boleh bertukar milik secara bebas. Syarikat tersebut dianggap sebagai sebuah entiti yang sah dan ditubuhkan mengikut Memorandum dan Artikel Persatuan.



Status Undang-Undang

v. Syarikat Koperasi

Ia merujuk kepada sesebuah persatuan sukarela yang bilangan ahlinya tidak terhad dan didaftarkan di bawah Akta Koperasi 1993. Dana adalah milik bersama untuk memenuhi keperluan ahli.

vi. Perbadanan Awam

Ia merujuk kepada sebuah perbadanan yang ditubuhkan di bawah Akta Parlimen atau Dewan Perundangan Negeri.

vii. Lain-lain

Ia merujuk kepada semua pertubuhan lain yang tidak termasuk di mana-mana kategori yang tersebut di atas.



Bilangan Orang Yang Bekerja

Bilangan Orang Yang Bekerja

Pekerjaan meliputi semua orang yang bekerja dalam bulan Disember atau tempoh pembayaran gaji terakhir dalam tahun rujukan. Bilangan orang yang bekerja dikategorikan seperti berikut:

i. Pemilik yang bekerja + keluarga tidak bergaji

Kategori ini merujuk kepada semua pemilik perseorangan dan rakan niaga sambilan atau sepenuh masa, yang terlibat secara aktif dalam kerja-kerja pertubuhan. Untuk keluarga tidak bergaji, yang ditakrifkan sebagai semua ahli (sepenuh masa atau sambilan) isi rumah atau mana-mana pemilik pertubuhan yang melaksanakan tugas dan kerja yang ditetapkan untuk minimum atau satu pertiga daripada waktu kerja biasa untuk penubuhan.

ii. Pekerja bergaji sepenuh masa

Ini ditakrifkan sebagai semua pekerja bergaji yang bekerja sekurang-kurangnya 6 jam sehari dan sekurang-kurangnya 20 hari sebulan.



Bilangan Orang Yang Bekerja

iii. Pekerja bergaji sambilan

Ini ditakrifkan sebagai semua pekerja bergaji yang bekerja kurang daripada 6 jam sehari dan / atau kurang daripada 20 hari sebulan.



Gaji dan Upah

Merujuk kepada pembayaran kasar yang dibayar kepada pekerja sepanjang tahun rujukan, termasuk gaji, upah, bonus, komisen, bayaran lebih masa, pemecatan gaji dan elaun sebelum ditolak Caruman pekerja kepada Kumpulan Wang Simpanan Pekerja (KWSP), Skim Keselamatan Sosial atau mana-mana potongan lain. Elaun kepada pemilik yang bekerja, rakan niaga yang aktif dan pekerja keluarga tidak bergaji tidak termasuk.

Nilai Harta Tetap

Harta meliputi semua barangan, baru atau terpakai, ketara atau tidak ketara, yang mempunyai jangka hayat ekonomi produktif lebih daripada satu tahun. Nilai yang dilaporkan adalah pada akhir tahun rujukan dan adalah mengikut buku akaun unit yang melapor.



Jualan / produk yang diproses / dipasang

Ini merujuk kepada jualan barang buatan sendiri pada tahun rujukan, sama ada dalam tahun rujukan atau tahun sebelumnya. Jualan perlu berkait kepada tahun di mana kawalan mereka ke atas produk-produk yang diserahkan oleh sesebuah pertubuhan kepada pembeli.

Kos bahan mentah / komponen / bahagian yang digunakan

Perkara ini termasuk semua barang yang dimiliki oleh pertubuhan ini pada tahun ini untuk menghasilkan pengeluaran pertubuhan ini. Bahan yang digunakan dalam pengeluaran harta tetap untuk kegunaan pertubuhan ini sendiri juga hendaklah dimasukkan.

Bahan Pembungkusan dan Penyimpanan

Nilai bahan dan bekas pembungkus yang digunakan pada tahun rujukan.



Skop dan Liputan

Penyiasatan Pembuatan Tahunan:

- Mulai MSIC 2000 (selang 3 tahun) – 2003, 2006, 2009, 2012 ; dan
 - 30% daripada jumlah pertubuhan individu tanpa wajaran.
- Penyiasatan ini meliputi semua pertubuhan yang berdaftar yang terlibat dalam aktiviti pembuatan sebagai aktiviti utama dimana ia meliputi 259 industri diklasifikasikan di bawah Klasifikasi Standard Perindustrian Malaysia / Malaysia Standard Industrial Classification (MSIC).
- MSIC 2000 – Tahun 2003 dan 2006
 - MSIC 2008 – Tahun 2009 dan 2012



Pemboleh Ubah


